The Senior Management, All Pakistan Fertilizer Dealers Association (APFDA) met with the Chairman, FBR and submitted the issues of Fertilizer Dealers in Pakistan.

Discussion was started on the prescribed agenda written above.

- 1. Mr. Ghulam Ahmad, Chairman, APFDA started with increase in Minimum Tax based on turnover from 0.50% to 0.75% on the dealers of Fertilizer with effect from the tax year 2020.
- 2. Mr. Sheikh Arshad Iqbal, Founder Chairman, APFDA debated that Rate of 0.50% was too high for the Fertilizer Dealers and now enhanced rate of 0.75% is totally unbearable & un-realistic.
- Secondly, Inter-dealer business and sales to sub-dealers or retailers, being withholding agent are liable to deduct tax @ 4%/4.5% at the time of making payment. This is totally not justified or highly excessive.
- 4. Exemption from withholding tax is required or reduction to 0.25% as in case of Sugar.

The Chairman, FBR listened our delegation and asked questions. After a long conversation, the Chairman, APFDA agreed

Meeting of APFDA and Agriculture Task Force, Punjab was arranged to discuss the advantages of Mandatory APFDA Membership for issuance of Government License to the Fertilizer Dealers in Punjab, on the date mentioned above.

Secretary General, APFDA elucidated the advantages of "Mandatory Membership" to the Additional Secretary, Task Force in an amicable atmosphere. He said, our proposal would address different issues like Hoarding, Undue Prices and Unnecessary Shortage etc.

- (a) Firstly, at the hoarding time, other stockiest who are not from fertilizer dealers community jumped in the market and create difficulties in the market, especially for farmers. They are completely ignorant from the fertilizer and subject industry. Eventually, blame goes to the fertilizer dealers.
- (b) Secondly, this is highly sensitive item and Government of Punjab/Provincial Government itself is taking care and monitor the fertilizer prices. When mafia enters (they are not from fertilizer sector, they are Rickshaw Drivers, Daily Wagers and other elements of mafia) complain of undue price starts.
- (c) Thirdly, the subject request will eradicate other culprit elements to enter in this trade periodically.

For further justification and validation, he added that

- 1. The association is well aware of all fertilizer dealers in four provinces of Pakistan.
- 2. Almost all of them got good affiliation with each other and they hail from respectable families doing their business in a good way.
- 3. Moreover, Inter-dealer trade has built strong business bonds in between all of them.
- 4. APFDA can identify and eliminate the culprits (Actual cause of deterioration in the fertilizer market) under the sagacious patronage & direction of the Agriculture Task Force, Punjab.

The Addl: Secretary, Task Force appreciated our thoughtfulness to ameliorate fertilizer dealers community and was convinced in the primary discussion. He ordered to come with the written proposal in next week.

- 5. Mr. Nadeem Yaseen Joined late due to his prior commitments and schedule.











- 5. Mr. Zaheer Abbas shared his experience regarding fine practice in district Gujranwala. He said this regular exercise is harassment and irritation for fertilizer dealers.

- 6. He listened the debate and gave his views that if the CTD is a policy given by the concerned government authorities to save lives then everybody should follow the state rules & regulations. Anyway, I would discuss on the matter with the relevant authorities to collect data on specific commodity only.
- 7. It was discussed that Joint meeting will be arranged in the presence of APFDA representatives to further debate on CTD.
- 8. He agreed that it is apparently not possible to collect CNIC of 10 MLN Tons fertilizer buyers annually. Secondly, he accepted the logic that customers do not often carry CNIC to the dealers and thirdly some are reluctant to give their personal numbers. However, data regarding sale of explosive material can be collected.
- 9. He said that the APFDA point-of-view regarding recent Fine & Catch-Ups of Fertilizer Dealers is logical and they should be handled in a proper way. During the said meeting, Mr. Secretary called the Additional Secretary, Task Force and advised him to work on APFDA agenda, given by our delegation.
- 10. It was also directed to stop taking action against dealers including regular practice of Fine without receipts.
- 11. Mr. Secretary gave his consent to have joint meeting with all concerned departments and representatives of APFDA shall be involved in the meeting for sharing of news & views.


to stop the practice of undue fines. Likewise, Mr. Abdul Hannan spoke on unity, understanding and one platform.
